The Club President, Show Chairperson, Cluster Show Chairpersons, Assistant Show Chairpersons and Judges' Liaison will not handle dogs at their club's shows.

PUBLICATION RIGHTS: By entering this show, all owners, handlers, breeders and kennels agree that all rights to televise, videotape, photograph, advertise, promote and publicize or otherwise exploit this show, or the persons or animals participating in it or the results of the competition before, during or after the event, shall belong solely to The American Kennel Club and their respective assigns, including the use of the names, likenesses or biographical matter of all dogs, owners, handlers, breeders and kennels participating in the show and no such owner, handler, breeder or kennel shall allow any other party to make commercial use of any videotape or photograph of any person or animal participating in this competition.

AKC National Owner-Handled Series

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers.

Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form. Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS. Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. **Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers*, household members and current assistants** to professional handlers may not exhibit the dog in any NOHS competition during the entire show.**

Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

- If the Best of Breed/Variety winner is Owner-Handled competition eligible, it will automatically be Owner-Handled Best of Breed/Variety and be eligible to compete in both the regular as well as the Owner-Handled group.
- If the Best of Breed/Variety winner is not eligible for Owner-Handled competition and the Best of Opposite Sex to Best of Breed/Variety is eligible, the Best of Opposite Sex to Best of Breed/Variety will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed/Variety.
- If neither the Best of Breed nor the Best of Opposite Sex to Best of Breed/Variety are Owner-Handled competition eligible and Select Dog & Select Bitch are both eligible, the judge is to choose Best Owner-Handled exhibit from the Selects and eligible Winners Dog or Winners Bitch.
- If one of the Selects is eligible, excuse all Champions and non-regular class winners of the same sex and then choose Best Owner-Handled exhibit from the remaining dogs of the opposite sex including the eligible Winners.
- If Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog remaining in the ring including Winners Dog or Winners Bitch as Owner-Handled Best of Breed/Variety.
- If the Best of Winners is eligible, the other Winner is ineligible since it was defeated.
- No class dogs other than the Winners Dog & Winners Bitch are eligible to return to the ring.

The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed or in Best of Winners competition.

*Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.

**A current assistant is defined as anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any time during the cluster/weekend. Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS.

A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required.

The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

At the discretion of the judge, the following breeds may be judged on the ground or on a ramp through all levels of competition including Group and Best in Show judging: Lagotti Romagnoli, American Water Spaniels, Clumber Spaniels, English Springer Spaniels, Field Spaniels, Welsh Springer Spaniels, Cirnecchi dell'Etna, American Staffordshire Terriers, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Finnish Spitz, Keeshonden, Entlebucher Mountain Dogs, Finnish Lapphunds, Norwegian Buhunds, Polish Lowland Sheepdogs, Spanish Water Dogs and Norrbottenspets (Misc.).

At the discretion of the judge, the following breed may be judged on the table or a ramp through all levels of competition including Group and Best in Show judging: Mudik (Misc.)

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on the ground, a ramp, or on a table: Boykin Spaniels and Whippets.

The following breeds must be judged on a ramp through all levels of conformation competition: Sussex Spaniels, Basset Hounds, Bulldogs, Chinese Shar-Pei and Chow Chows. This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4-6 Month Beginner Puppy Competition, the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions.

Ramps can be used in emergency situations to judge any breed. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.

For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breeds.

The Club and its Superintendent caution all persons entering the show site and show grounds against all hazards which may exist, including, but not limited to: Condition of the site/grounds, parking/loading/unloading areas, entrances, floors and stairways, elevators and escalators, floor coverings, walkways, tenting/canopies, electrical appliances, cords and fittings, exercise pens, and the presence of animals. All persons should take into consideration this is a sporting event and dress, act and exercise caution appropriate for the activity involved. All persons entering the show, the grounds, site and show areas for whatever purpose do so entirely at their own risk. By virtue of entering the show, the entrant has indicated their acceptance of the terms listed in the premium list and assumes all risks involved.

NO PRACTICING ALLOWED IN RINGS AT ANY TIME.

Dogs May Arrive any time prior to their scheduled time of judging. **Dogs not required for further judging will be excused.**
Judges Will Not Wait for Any Dog Holding Up a Class. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

All Dogs Present must be held on leash or confined to their crates except when being judged or when in the exercising ring.

No gasoline or diesel generators are permitted inside any building or within 100 feet of any tent in which this dog show is conducted.
As specified in Chapter 12, Section 4 of the AKC Rules Applying to Dog Shows, information contained on the entry form is required to be published in the club's show catalog. This information is also subject to publication in other media.

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the event's Show Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to, snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

Attention Exhibitors

The Clubs, the Superintendent, their agents, employees, members, etc. assume no responsibility for any loss or damage, or injury sustained by exhibitors, handlers, or to their dog(s) or property and further assume no responsibility for injury to children.

The SHOW GROUNDS will be available to exhibitors **NO EARLIER THAN 12:00 Noon Monday, February 18.** EXHIBITORS PLEASE NOTE: The gate will close between 11:30 P.M. and 6:30 A.M. on Wednesday, Thursday, Friday & Saturday evenings. Show site must be vacated immediately following Best in Show judging on Sunday. Arrangements may be made for persons to stay overnight on Sunday. **THESE RESERVATIONS MUST BE MADE WITH CLUSTER SHOW CHAIRPERSON LEAH R. JAMES (850) 445-5409 BY FRIDAY AT 5:00 P.M. NO ONE WILL BE ALLOWED TO STAY AFTER THE SHOWS WITHOUT RESERVATIONS.**

EXHIBITOR PARKING: Please note parking permits must be displayed at all times. **Day parking will be \$5.00 payable at the gate.** Exhibitors will be responsible for keeping the area around their vehicle and grooming area clean at all times. **Handicapped Parking** is limited and is available on a first come, first served basis.

MOTOR HOME PARKING: Will be on a first come, first served basis only. No saving of space. **Fees for Overnight Parking are \$40.00/Night.** All motor homes/trailer units will be charged this fee whether a hookup is utilized or not. One additional parking pass will be issued at no charge for a towed vehicle; this pass is not transferable to another vehicle. Please be considerate of the amount of space each unit takes. **ELECTRIC MAY NOT BE PIGGY BACKED; WATER MAY BE PIGGY BACKED.** The electrical, water & limited sewer hookups throughout the park are controlled by the North Florida Fairgrounds. The clubs cannot guarantee the functionality or capacity of the available outlets but will make every effort to ensure that all work. To maximize access to water where possible, the clubs suggests the use of water T's to permit sharing of spigots. Water T's are not furnished by the clubs; exhibitors must supply their own. It is highly recommended that motor homes bring at least 100 feet of water hose and 100 feet of heavy duty electrical cord. Electrical adaptors may be needed for use of some hookups.

LIMITED CRATING is available at ringside in buildings #1 & #2 provided that, in the opinion of the Event Committee, no obstruction or safety hazard is created. Crates must be stacked wherever possible and must be removed immediately after completion of that breed's judging.

GROOMING: There will be a 15 minute loading and unloading time limit for vehicles in front. The clubs will require that you leave your vehicle running, lights on and unlocked. If the 15 minute limit is not observed, the vehicle owner risks the vehicle being moved by a club representative or towing. This is necessary for complying with Fire Marshal regulations. Buildings #1 & #6 are the designated grooming buildings. **ALL INSIDE** grooming must be done in buildings #1 & #6. Electricity is available there, but no water. Please conserve grooming space or risk being moved or removed entirely.

Dogs may be left in the grooming building overnight, however the grooming building will not be locked. **ALL CRATES MUST BE IDENTIFIED WITH NAME OF OWNER/HANDLER.** All aisles must be left clear. Exhibitors are responsible for keeping their area clean and trash properly disposed of in trash cans located throughout the building.

FOOD SERVICE: Concessions will be available on the grounds.

TROPHIES: The clubs reserve the right to substitute a prize of equal or greater value. **All prizes must be claimed on the day of each show. None will be mailed.** All unclaimed prizes become the property of the clubs.

All unclaimed cash prizes will be added to Best in Show daily.

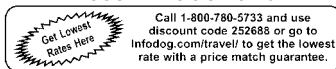

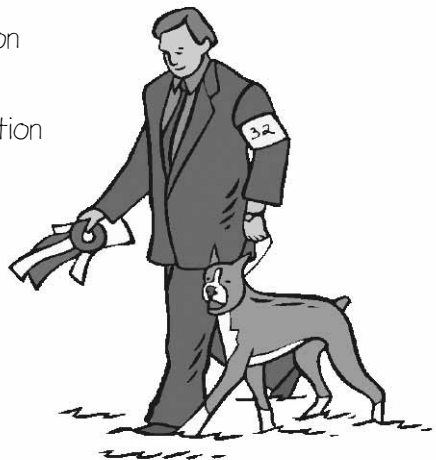

AKC Code of Sportsmanship

PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
